- And so.....



Engineering for Change Reclaimed materials


- All materials will be selectively reclaimed.
- Materials reclamation shall be a designed process.
- All reclaimed materials shall be selectively stockpiled.
- All reclaimed materials shall be re-processed to extract maximum value from them.



Unloading our landfill sites

- All construction and demolition concrete & masonry was considered as waste & sent to landfill sites.
- Major problem is finite space in landfill sites.
- Negative affect on decomposition of organic material in landfill sites.
- Initiated reclaimed concrete & masonry research with UKZN & international partners.


Green procurement: Reclaimed concrete

- This is bringing change to our organisation and the way we do business.




Sustainability

- No formal policy
- No definition
- No formal specification
- Response has therefore been mixed from Consultants, contractors and staff.
- Do we specify sustainability?
- Perhaps it will offer us a standardised minimum and point of departure for managing all the green-shoots.



Is GreenRoadsSA the answer?





- We do not have a policy or definition for sustainability in roads
- However our contractors have responded positively. Why they see that the can achieve a better bottom line through sustainable practices and also there is legislation that must comply with.
- Consultants at best their response has been mixed. Why they think that it will affect their bottom line negatively ie they will have to spend time and money getting up to speed with new and better ways of doing things they have the grocery list approach which they know. There is no legislation that they need to comply with, BUT what about ECSA code of conduct. Slowly some consultants are realising that sustainability has some brand value, particularly those with an international foot-print are needing to comply with stating issues of sustainability forming part of good corporate governance and this needs to be declared so there is some light.
- What we have done is look to to GreenRoadsSA to offer us a point of departure for policy, specification and monitoring mechanism for meeting of specification for all parties.
