- Roads Sector must accept the consequences
 - Deterioration of already poor road infrastructure
 - Less skills to deal with increasing problems
 - Downward spiral



Answer

- "YES"

- Roads Sector must take responsibility and drive the process
 - This affects everyone in the Roads Sector
 - » Clients
 - » Consultants
 - » Contractors
 - » Laboratories
 - » Material Suppliers
 - No one else will!!!



Problems

- Extremely poor quality control on site

- Need for materials/quality control specialist seemingly not recognised
- Expertise of experienced materials practitioners not recognised
- Proliferation of Project Managers/Administrators
 - Limited materials experience
 - SCM specialists



Problems

- Labour issues
 - Sparse and aging expertise (NQF 5 and higher)
 Extinction of the species threatens
 - Difficulty in retaining experienced Laboratory staff (NQF 2 – 4)
 - NQF Objective Redress of past discrimination
 - Lack of qualification blocks recognition of skills (TASK)



Problems

- No career path for specialists in the Materials
 Field
 - No active qualifications for NQF levels 5 and higher
 - No active qualification for NQF levels 2 4
 - SAQA 49058 National Certificate Construction Materials Testing - NQF 2
 - SAQA 49017 National Certificate Construction Materials Testing - NQF 3
 - SAQA 48817 National Certificate Construction Materials Testing - NQF 4
 - Specialised field
 - Small numbers of personnel

- SAQA
 - (South African Qualifications Authority)
 - Oversees development of National Qualifications Framework (NQF)



- NQF
 - (National Qualifications Framework)
 - Facilitate access to, and mobility and progression within, education, training and career paths;
 - Accelerate the redress of past unfair discrimination in education, training and employment opportunities.



- -CETA
 - (Construction Education and Training Authority)
 - CETA's primary objective is to influence the course of training and skills development in the construction sector.
 - Ratify workplace skills plans.
 - Establish learnerships.
 - Little past success!!!



- QCTO
 - (Quality Council for Trades & Occupations)
 - Develop and recommend qualifications in a training Sector to SAQA.
